1. Books open at 7:45—no refunds after show starts.
2. Stallions are prohibited.
3. Negative Coggins Required - all will be checked.
4. Pre register by postmarked Nov 8th \$6.00 per class or \$55 to ride all day....
AFTER Nov 8th \$8.00 per class or \$70 to ride all day.
5. **MUST** enter Halter to be qualified for High point prize or All around Champion.
6. KSC may not be held liable for accidents or injuries to horse or rider.
7. High Point and All around is calculated on a one horse one rider combination.
8. Ribbons will be handed out 1st place-6th.
6 point system 1st=6 2nd=5 3rd=4 4th=3 5th=2 6th=1
9. AQHA rules will be followed.
10. Judges' decision is FINAL.
11. KSC reserves the right to change, cancel, combine classes, alter courses, and do all things necessary to compensate for excessive or inadequate entries.
12. Concessions will be available.
13. All children must be accompanied and supervised by an adult.
14. Dogs must be on a leash or held in hand at all times.
15. Helmets are required for English and encouraged for Western.
